## RELEASE AND WAIVER OF LIABILITY

(Read Carefully Before Signing)

By signature affixed below, I certify that I am fully aware of the hazards involved in the sport of hunting and understand the necessary actions to provide for the maximum possible safety while hunting. I am also aware of the hazards associated with a farm and/or ranching operation. I understand that hunting is inherently dangerous, and that while the hazards may be reduced by proper safety procedures, the danger cannot be eliminated. I willingly assume such hazards, risks and dangers.

In full recognition of such dangers, and in consideration of being permitted to enter the premises of landowner and participate with Double J Outfitters, Inc. in the sport of hunting, the undersigned, on behalf of the undersigned, next of kin, legal representatives, heirs and assigns, and any guests (hereinafter collectively referred to as the "Undersigned"), hereby releases, waives and discharges John Borer and Double J Outfitters, Inc., its owners, employees, agents or contractors, including all landowners (hereinafter "Releasees"), from all liability to the Undersigned for any and all loss, claim or damages resulting therefrom, on account of injury to person or property, including death, while participating in the sport of hunting and shooting. This release and waiver is intended to be complete, as the Undersigned agrees to hold harmless and indemnify Releasees for any injury that might result while involved in the sport of hunting and shooting on their premises.

The Undersigned hereby assumes full responsibility for the risk of bodily injury, death or property damage while on the premises of Releasees, whether caused by the actions or inactions of the Undersigned, Releasees, or other persons on or off the premises, and whether arising from negligence or otherwise

The Undersigned hereby agrees to indemnify, save and hold harmless the Releasees from any loss, liability, damage or cost they may incur arising from or related to use of the premises of Releasees for hunting by the Undersigned.

The Undersigned hereby agrees to pay all costs and expenses, including reasonable attorney fees and court costs, incurred by the Releasees in any litigation arising from or related to use of the premises of Releasees for hunting by the Undersigned.

The Undersigned hereby agrees that this release, waiver and indemnification agreement is intended to be as broad and inclusive as permitted by the laws of the State of New York, and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect.
